Sustainability & Capacity Building Committee (SCBC)

- Randy C. summarized the meeting with EOR at NWRPC
 - Methods and technologies to reduce eutrophication, algal blooms, and sedimentation in Long Lake
 - Alum treatment is a possibility for the North Basin to reduce algal blooms
 - Alum treatment requires phosphorus study to determine source of phosphorus (would take 1-2 years)
 - Treatment would create lasting effects for up to 10 years potentially
 - Nanobubbles is a possibility for other areas (bays, Holy Island area) to reduce sedimentation
 - Permits are a major challenge
 - The recommendation is to wait and see what happens with DNR permitting for a different lake group
 - These methods are expensive and will require extensive fundraising
